


Figure 1. Function Patch Design by Wyatt Bryant

This is the Proposed Guidelines from the inductions committee and their chairman, Gabe Plichta, to be approved on at the April meeting.

#### Introduction

The Inductions Committee, in conjunction with Tutelo Lodge #161, have created a policy that will adhere to the new Scouts BSA *Guide to Safe Scouting*, in conjunction with the Order of the Arrow's *Guide to Inductions*, in order to create a welcoming and inclusive environment for people of all race, gender, ethnicity, disability, etc. This policy, listed below, will seek to keep Tutelo Lodge #161 in accordance to all *Guide to Safe Scouting* and *Guide to Inductions*, Ordeal, Fellowship, and other Lodge/Chapter activities are to be carried out. Adults are to be classified as any participant that is of the age of 18 and over, for the sake of the *Guide to Safe Scouting*.

## Section 1: Concerning Actions Outside of the Inductions Process

#### Adult Supervision

There is to be at least two registered adult individuals over the age of 21 present at every event. In every event where there are to be females present, there must be at least one registered adult female individual over the age of 21. Oneon-one contact between youth (age between 12 and 18) and "youth-plus" (age 18 to 21) or adult (age 21 and over) is strictly prohibited and must be done in the presence of another registered individual. All members who are of the age of 18 and over must have taken and passed "Youth Protection Training", in order to be familiar with the *Guide to Safe Scouting* and its principles.

## **Sleeping Accommodations**

## Tenting

Separate tenting between male and female adults and youth must be strictly enforced. Youth males and youth females are not to sleep in the same tent, regardless of relationship (e.g., brother/sister, partners, etc.). Adult males and adult females may sleep in the same tent if they are spouses. Adults and youth are not to sleep in the same tent, even if they are family, unless it is a Cub Scouting event. Youth sharing tents must be at most two years apart of each other.

## Lodging/Cabins

Separate lodging and cabins must be provided for male and female youth, as well as male and female adults. If separation cannot be provided, for any other reason, it must be referred to the *Guide to Safe Scouting*. Under no circumstances, unless extenuating, may adults and youth of the same gender share lodging. Males and females may not be lodged with each other, with no exceptions.

#### Restrooms and Latrines

Both youth and adults may not share the same showering and restroom facilities, unless each shower and restroom are separated from each other. Males and females may not share the same shower and restroom facilities, regardless



of separation and privacy installations. If separate facilities cannot be provided, separate showing times must be adhered.

#### Other Program Requirements

The buddy system should be used at all times. The use of smartphones, cameras, mirrors, drones, etc., in places or situations where privacy is expected is prohibited. All aspects of the Scouting program are open to observation by parents and leaders; the BSA does not recognize any secret organizations as part of its program. Hazing and initiations are prohibited and have no part during any Scouting activity. All forms of bullying and harassment including verbal, physical, and cyberbullying are prohibited. Inappropriate public displays of affection are prohibited. Sexual activity is prohibited. Appropriate attire is required for all activities. Any and all violations of the *Guide to Safe Scouting* must be reported to the adult lead at every function; reporting must follow the *Guide to Safe Scouting*'s adherence of the policy.

## Section 2: Regarding the Inductions Process Adult Supervision

All activities must adhere to the *Guide to Safe Scouting*'s policy on adult supervision. Adults must be in the presence of all Induction Committee activities and actions, and aware of their decisions regarding the safety of all participants in the process (i.e., Ordeal Candidates, New Ordeal Members, Brotherhood Candidates, and New Brotherhood Members).

## **Clan Assignments**

Clans are to be assigned as follows:

- Females and males are to be kept in separate clans. There should be no mixing of males and females, regardless of clan sizes. This is not to be followed by Brotherhood Candidate clans.
- Each clan is to have a fully trained for Ordeal Candidates and a fully trained for Brotherhood Candidates. In Ordeal Candidate clans, male and female clans must have either a male Elangomat or a female Elangomat. Clans may grow in size, depending on the availability of male and female Elangomats.

## Sleeping Accommodations

Regarding Ordeal Candidates between the time of the end of the Pre-Ordeal Ceremony, and the agreed upon "wakeup" time, the Inductions Committee is responsible for creating a safe environment for female participants when sleeping. Males and females are not permitted to sleep with each other during this time, regardless of age and relationship status. If caught, the Candidates will be asked to return to the Main Camp while an investigation takes place and may be asked to leave the Ordeal Weekend. If possible, sleeping areas should be separate for each gender (e.g., separation by distance), but accommodations may be made if this cannot be accomplished. Alternate accommodations may be given to those with any form of a disability.

#### Latrines and Restrooms

Will follow the above-mentioned policy.



#### Service

There is not to be any form of discrimination done towards the service project of both female and male clans, either in assigning of projects or difficulty of projects. However, if there is is/are candidate(s) with any form of a disability, an alternate project may be assigned to said individual that they are comfortable with doing. If a candidate does not feel comfortable (to a degree) with a certain project, they possess the right to request for an alternative assignment.

#### Other Program Requirements

All other program requirements are to be followed with strict adherence.

## Section 3: Regarding Discrimination

All forms of discrimination are prohibited, and no Ordeal Candidate or Order of the Arrow member is to be discriminated against, regardless of race, gender, ethnicity, sexual preferences, etc.

## Section 4: Regarding Actions Taken Against Those Who Violate the Above Policies

If it is reported that a violation has occurred of any of the above policies, Tutelo Lodge #161, the Blue Ridge Scout Reservation, the Blue Ridge Mountains Council, the National Organization of both Scouts BSA and the Boy Scouts of America, and other law enforcement agencies reserve the right to open an investigation into the matter. Individuals may be required to suspend activities at the event in question, as well as future events, until a thorough investigation is complete, and may be removed from the event if deemed necessary. The aforementioned organizations reserve the right to remove anyone from any event, though should not do so in a discriminatory way. The aforementioned organizations also hold the right to deem any form of punishment necessary, except for hazing or capital punishment. All other local, state, and federal laws are to be followed.
